BCF's Response to COVID-19

e are stronger together. This is a phrase we hear often today, but how do we know it's true? Imagine our forests. Individual trees can flourish on their own, but they are stronger when living together—with other trees nearby they share nutrients, create a local ecosystem in which they thrive, and act as buffer for each other during inclement weather. A forest is greater than the sum of its parts.



Community foundations help create a similar environment by supporting nonprofits that are critical to the place we call home. Specifically, Bainbridge Community Foundation (BCF) works in partnership with dozens of local nonprofits through promoting collaboration, analyzing community needs, awarding grants to meet those needs, and connecting donors to nonprofits. In 2019, BCF had one of its best years yet by having a remarkable fundraising year, ramping up its programmatic and educational work through trainings and workshops, and creating new partnerships with local organizations to support affordable housing and student assistance programs.

The success of 2019 made BCF uniquely positioned to respond to the consequences of the COVID-19 crisis. As of October 31, 2020, BCF has taken the following actions to support the community:



ACTIVATED our Community Response Fund to provide financial resources to local nonprofit organizations for urgent health and human service needs.



PARTNERED with Rotary Club of Bainbridge Island in supporting the Community Response Fund (CRF). To date, through the CRF, BCF has awarded almost \$131,000 in grants to support nutritious food distribution programs, emergency supplies, childcare, housing and rental assistance, and other essential services.



CONDUCTED three surveys to get real-time information about the changing needs for PPE, operating funding, and more.



HOSTED virtual education workshops on financial literacy and nonprofit resilience, with plans to ramp up training in 2021.



AWARDED a total of \$1,979,982 in grants through October, of which \$861,295 has been dedicated towards COVID-19 emergency relief. Total grantmaking by BCF to date is more than \$16.5 million.



REFOCUSED the 2020 Community Grants Cycle to make impact of COVID-19 a priority, and reached a record-hitting year of awarding \$507,313 in grants to local nonprofits.



RELEASED RESTRICTIONS on unspent Community Grants Cycle funds from 2019 so that organizations could use the money for unexpected costs.



CONVENED weekly and biweekly meetings with nonprofit leaders to provide support and assess their needs and encourage collaboration.

How To Support Our Work

hether you have lived on the island for generations or moved here more recently for the quality of life, it's clear that Bainbridge Island has a strong and unique sense of community. Island residents are able to maintain a high quality of life primarily because of its vibrant nonprofit sector.

We respond to the changes in our community as it grows, and remain flexible in times of need. Through the support of donors at all levels—from \$10 to \$10,000 or more—BCF has been able to award a total of \$1,979,982 in grants so far in 2020. The impact of the work of our grantees is truly inspiring—and the need for support is only increasing each year. It is never too late to get involved.

- Community Grants Cycle Partners: Donations support the Foundation's annual grantmaking program for nonprofit organizations serving the Bainbridge community. Grants are awarded to 501(c)(3) nonprofits doing work in all sectors of the community.
- Capacity Building Grants Partners: This special grant program helps nonprofits become more effective by building their capacity to function as stronger, more efficient organizations.

- **Community Response Fund:** This fund provides financial resources to nonprofit organizations for urgent health and human service needs in our community, especially during times of economic hardship or human or natural disaster. This fund has and will continue to award grants to local nonprofits that have been affected by COVID-19.
- Housing Action Fund: This fund addresses the critical need for affordable housing on Bainbridge Island by supporting both acquisition and bricks-and-mortar housing programs.
- **Scholarship Funds:** Annual scholarships awarded to graduating Bainbridge seniors pursuing higher education.
- BCF Endowment Fund: Gifts to permanent endowed funds ensure there will be ongoing support for our community for generations to come.

Don't Miss Out on Tax Incentives for Giving in 2020

The CARES Act has created a number of programs that make charitable giving in 2020 particularly advantageous. For example, as a result of the increase in the standard deduction in 2018, fewer people are eligible to itemize charitable deductions. But the CARES Act allows anyone to itemize charitable deductions of up to \$300 while still claiming the standard deduction. And for those who do itemize, the benefits of charitable giving are even better. Under the CARES Act, you can deduct up to 100% of your adjusted gross income (AGI), for all of your 2020 cash donations. Normally, this limit is 60% of AGI.

It's a great year to make charitable gifts and also great year to open a Donor Advised Fund at BCF. **BCF** is offering a donation of \$500 to the BCF grantee of your choice if you open a Donor Advised Fund in 2020. Donor Advised Funds can help you get an immediate tax deduction for your gifts, while taking some time to decide what causes you wish to support. We encourage you to consult with your tax advisor to see how you might benefit from these opportunities.
